Consolidated cases may not be tried until all cases are ready for trial. Although consolidation with a case that is not yet ready for trial may delay a case that is ready for trial, that alone is insufficient reason to deny consolidation where all other factors favor joint trial. If the motion to consolidate is allowed, the cases will be consolidated in the session where the earliest filed case is pending unless (a) the judge in that session orders, in the interest of justice or with the consent of all parties, that the cases be consolidated in a session where a later filed case is pending, and (b) the judge in that other session agrees to accept the consolidated cases.
