The formula for calculating incidents is the number of recorded accidents in that year multiplied by 200,000 (to standardize the accident rate for 100 employees) and then divided by the number of employee labor hours worked. So the formula, again, is  $\text{accident rate} = (\text{number of accidents} * 200,000) / \text{number of hours worked}$ .

The principle direction of force (or PDOF) will fold a vehicle's exterior in the direction the collision occurred. Traffic Accident Reconstructionists can also tell which lights were on during a collision, even if they are off once the collision occurs (an effect called "hot shock").

In the case of drink-driving, the risk of a road traffic crash starts at low levels of blood alcohol concentration (BAC) and increases significantly when the driver's BAC is  $\geq 0.04$  g/dl.
