The process of applying for a travel document is similar to submitting other applications to the USCIS and follows this basic pattern: File your Form I-131 with supporting document to the appropriate USCIS office. Attend the biometrics (fingerprinting) interview at the USCIS.

Adjustment of Status applicants may apply for advance parole by filing Form I-131, Application for Travel Document. CitizenPath recommends that you file Form I-131 at the same time as your Form I-485. When you file them concurrently, there is no additional USCIS filing fee for Form I-131.

In order to use Form I-131, Application for Travel Document to apply for a Reentry Permit, you must have a Green Card or a conditional Green Card and you must be in the United States when you apply for the permit. If you are 14 to 79 years old, you must also go to a special appointment called a Biometrics Services appointment, for fingerprinting.
